RESEARCH PROFILE

I have been a researcher at Université Gustave Eiffel since 2011, following several years of teaching at various universities. Originally from Galicia, Spain, I earned a bachelor's degree from the University of Nantes in 2002 and completed my Ph.D. at the University of Paris 7 in 2010. In addition to my academic career, I have hands-on experience in public policy, having served as a project manager for the French Prime Minister in 2010-2011 and contributing to a parliamentary report. In recent years, I have also acted as a consultant for international organizations such as UNCTAD, IMO, and AFD.

As a geographer specializing in transportation, my areas of expertise include ports, maritime transport, and global supply chains. I lead the Transport Geography module at the École Supérieure des Transports in Paris and coordinate a research seminar on maritime transport at the University of Paris 1 Sorbonne. I have also been a visiting professor at Kwansei Gakuin University in Japan for two semesters (2017 and 2019) and regularly teach at universities in Sofia (Bulgaria) and Djibouti.

In recent years, I have coordinated or contributed to several research projects, which have resulted in the publication of two dozen peer-reviewed academic papers. I have also guest-edited special issues for academic journals and currently serve on the editorial boards of two scholarly journals.
